fiscal year beginning October 1, 1994 and ending September 30, 1995, in the form attached hereto.

2. The Legislative Council appropriates the sum of \$18,000, from the general revenue account, to pay the fees and expenses under the consultant contract.

3. The Chairman of the Nation, the Chairman of the Legislative Council, and the Chairman of the Cultural Preservation Committee are authorized and directed to execute the consultant contract.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 14TH. day of OCTOBER, 1994 at a meeting at which a quorum was present with a vote of 1,262.0 FOR; 290.0 AGAINST; -0- NOT VOTING; and 211.0 [09] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






