**RESOLUTION NO. 94-449**

**WHEREAS, by Resolution 93-381 the Tohono O'Odham Legislative Council approved an attorney contract with the law firm of Gover, Stetson & Williams to provide legal representation with respect to certain of the Nation's water matters; and**

**WHEREAS, the attorney contract expired on September 30, 1994; and**

**WHEREAS, continued representation regarding water matters is required to protect the Nation's interests; and**

**WHEREAS, the approved budget of the Office of Attorney General for fiscal year 1995 includes funding of \$125,000., to continue the attorney contract for such year; and**

**WHEREAS, the Domestic Affairs Committee recommends approval of an attorney contract with Gover, Stetson & Williams for fiscal year 1995.**

**NOW, THEREFORE, BE IT RESOLVED THAT:**


- 1. The Tohono O'Odham Legislative Council hereby approves an attorney contract with the law firm of Gover, Stetson & Williams in the amount of \$100,000., for the fiscal year ending September 30, 1995 and in the form attached hereto.**


**2. The Chairman of the Nation is authorized and**




