  representation with respect to certain cases arising in
  California under the Indian Child Welfare Act ("ICWA");
  and
- WHEREAS, the attorney contract expired on September 30, 1994; and WHEREAS, continued representation regarding ICWA matters in California is required to protect the Nation's interests; and
- WHEREAS, the approved budget of the Office of Attorney General for fiscal year 1995 includes funding of \$10,000., for attorney contract in ICWA cases; and
- WHEREAS, the Domestic Affairs Committee recommends approval of an attorney contract with CILS for fiscal year 1995.

## NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Tohono O'Odham Legislative Council hereby approves an attorney contract with California Indian Legal Services in the amount of \$5,000., for the fiscal year ending September 30, 1995 and in the form attached hereto.
