**RESOLUTION NO. 94-452**

**WHEREAS, by Resolution No. 93-384 the Tohono O'Odham Legislative Council approved an attorney contract with the law firm of Rothstein, Donatelli, Hughes, Dahlstrom, Cron & Schoenburg (the "Rothstein Firm") to provide legal representation to the Nation with respect to matters associated with the operation of Desert Diamond Casino; and**

**WHEREAS, the attorney contract expired on September 30, 1994; and**

**WHEREAS, continued representation regarding the operation of Desert Diamond Casino is required to protect the Nation's interests; and**

**WHEREAS, Desert Diamond Casino has budgeted the sum of \$20,000., for continuation of legal representation in such matters; and**

**WHEREAS, the Domestic Affairs Committee recommends approval of an attorney contract with the Rothstein Firm for fiscal year 1995.**

**NOW, THEREFORE, BE IT RESOLVED THAT:**

- 1. The Tohono O'Odham Legislative Council hereby approves an attorney contract with the Rothstein**

**Firm in the amount of \$20,000., for the fiscal year  
ending September 30, 1995 and in the form attached  
hereto.**

**2. The Legislative Council appropriates the sum of  
\$20,000., to pay fees and expenses under the attorney  
contract, and authorizes and directs payment thereof  
from the budget of Desert Diamond Casino.**

**3. The Chairman of the Nation is authorized and  
directed to execute the attorney contract.**

at which a quorum was present with a vote of 1,526.0 FOR; -0-  
AGAINST; -0- NOT VOTING; and 237.0 [13] ABSENT, pursuant to the  
powers vested in the Council by Section 2(a) of Article VI of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
O'Odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
