

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Comprehensive Education Plan Budget Proposal with the
Tucson Community Foundation/Rockefeller Foundation)**

RESOLUTION NO. 94-454

WHEREAS, the Tohono O'Odham Nation adopted the Comprehensive Education Plan (CEP) for the Tohono O'Odham Nation in 1982 in which some of the goals and objectives were met; and

WHEREAS, the existing Comprehensive Education Plan is in dire need of revision to address the present educational system and diversity in governance and curricular structure; and

WHEREAS, the Tohono O'Odham Education Committee/Board of Directors and the Tohono O'Odham Education Department recognizes the need for the revision and will apply for a grant in the amount of \$5,000.00 with the Tucson Community Foundation/Rockefeller Foundation which requires matching funds in the amount of \$5,600.00 from the Nation; and

WHEREAS, the revision of the Comprehensive Education Plan will greatly improve education for all Tohono O'Odham.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby approves the proposed budget to the Tucson Community Foundation/Rockefeller Foundation in the amount of \$5,000.

BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council will set aside \$5,600.00 matching funds to be appropriated from the General Revenues Account.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 17TH day of OCTOBER, 1994 at a meeting at which a quorum was present with a vote of 1,160.0 FOR; -0- AGAINST; -0- NOT VOTING; and 603.0 [15] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


