

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Schuk Toak New Farm Predesign/Design
FY 1995 Supplemental Budget)**

RESOLUTION NO. 94-464

**WHEREAS, the Tohono O'Odham Nation agreed to a P.L. 93-638
Cooperative Agreement (No. 3-FC-32-00200, Council
Resolution No. 93-356) with the Bureau of Reclamation
("Reclamation") to complete predesign and design for the
Schuk Toak New Farm; and**

**WHEREAS, the Legislative Council understands that the Nation
incurred certain obligations under SAWRSA; and**

**WHEREAS, the Water Projects Office requests from the Tohono
O'Odham Nation, supplemental funding for FY 1995 to
cover those costs not now funded by Reclamation which
are necessary to complete predesigns and designs for the
Schuk Toak New Farm.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that it does hereby approve the
funding request and authorizes expenditures in
accordance with the attached budget.**


**BE IT FURTHER RESOLVED that funds in the amount of \$328,530.00
are hereby approved from the SAWRSA Trust Fund.**

**BE IT FINALLY RESOLVED that the Nation shall seek reimbursement
of funds previously advanced by the Nation for costs
which are the responsibility of the Secretary of the
Interior under SAWRSA.**






