- WHEREAS, the Legislative Council reaffirms its position that such assessments are unlawful and constitute an obligation of the United States under the Act; and
- WHEREAS, to date legal proceedings commenced by the Nation's

 Attorney General have not resulted in a final determination regarding liability for such assessments; and
- WHEREAS, CAIDD has initiated a proceeding in the United States
