

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Santa Rosa Health Center Land Expansion)**

RESOLUTION NO. 94-480

WHEREAS, the Gu Achi District Council has discussed and approved the proposed land expansion requested by the Santa Rosa Health Center, and;

WHEREAS, at the time when Santa Rosa Health Center was established; no land was set aside for future expansion as was confirmed by Indian Health Services; and

WHEREAS, the Gu Achi District Council has reviewed the proposed land expansion described in District Council Resolution No. 1094-93 and approves that land be used for health improvement purposes; and

WHEREAS, upon the approval of the proposed land expansion by the Santa Rosa Health Center a Cost Free Agreement shall be made between the Indian Health Services and the Tohono O'odham Nation.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves Resolution No 1094-93 submitted by the Gu Achi District Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH. day of NOVEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,665.0 FOR; -0- AGAINST; -0- NOT VOTING; and 98.0 [10] ABSENT, pursuant to the powers vested in the Council by Section 1(i) & c(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting


