

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointment of Albert Gomez to the Election Board
to fill Unexpired Term)**

RESOLUTION NO. 94-482

**WHEREAS, Article II, Section 1B of the Tohono O'odham Uniform
Election Ordinance empowers the Legislative Council to
appoint members to the Election Board; and**

**WHEREAS, Nancy Garcia resigned as a member of the Election
Board to avoid any conflict of interest due to her
appointment as Director of Tohono O'odham Enrollment
Department; and**

**WHEREAS, the vacated position has an unexpired term of three
years which will end in 1997; and**

**WHEREAS, the Election Board and Rules Committee jointly
interviewed applicants for the position and recommends
that Albert Gomez be appointed to carry out the
unexpired term.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham
Legislative Council that Albert Gomez is hereby
appointed to the Election Board to fill the remainder of
the unexpired term ending in 1997.**

**The foregoing Resolution was passed by the Tohono O'Odham
Legislative Council on the 10TH. day of NOVEMBER, 1994 at a
meeting at which a quorum was present with a vote of 1,763.0 FOR;
-0- AGAINST; -0- NOT VOTING; and 10 ABSENT, pursuant to the
powers vested in the Council by Section 1(b) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




