

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Memorandum of Agreement with the Bureau of
Indian Affairs for cooperative law enforcement operations
to control illegal narcotics traffic)**

RESOLUTION NO. 94-486

**WHEREAS, the Tohono O'odham Nation has recognized an increase
in the transportation of illegal narcotics from Mexico
across the Nation's lands; and**

**WHEREAS, the Nation has limited resources and manpower to
adequately interdict and eradicate illegal drug
transportation activities; and**

**WHEREAS, the Nation has requested federal appropriations to fund
ranger programs to curb these illegal activities; and**

**WHEREAS, the Bureau of Indian Affairs, Branch of Drug
Enforcement has offered resources and manpower to
address these needs; and**

**WHEREAS, the Domestic Affairs Committee and the Appropriations
Committee of the Legislative Council recommend
approval of the Memorandum of Agreement with the
Bureau of Indian Affairs in the form attached hereto.**

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Memorandum of Agreement with the Bureau of
Indian Affairs is approved.**
- 2. The Chairman of the Nation is authorized and
directed to sign the Memorandum of Agreement on
behalf of the Nation in the form attached hereto.**

3. **Within 90 days, the Chairman of the Nation and the Tohono O'odham Police Department shall report to the Legislative Council on the status and progress of activities authorized pursuant to the Memorandum of Agreement.**

4. **Any proposed termination of the Memorandum of Agreement initiated by the Nation shall require the prior approval of the Legislative Council.**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 22ND. day of NOVEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




