**WHEREAS, the Tohono O'Odham Nation is presently operating the
Behavioral Health Services Program under P. L. 93-638
contract with the Public Health Services, Indian Health
Services; and**

**WHEREAS, Resolution No. 94-393 approved the consolidation
structure combining the Health Department, Department
of Social Services and the Needy Family Food Program
into the "DEPARTMENT OF HUMAN SERVICES"; and**

**WHEREAS, any amendments affecting the Scope of Work or funding
levels of the contract shall be submitted for review and
approval; and**

**WHEREAS, the Department of Human Services requests the
following program title change: Division of Alcohol and
Substance Abuse; and**

**WHEREAS, the Department of Human Services/Division of Alcohol
and Substance Abuse has submitted a revised Scope of
Work and budget modifications (RAPA and Community
Based Training) for review and approval by the Tohono
O'Odham Legislative Council.**

NOW, THEREFORE BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby approve the revisions to the Program Title, Scope of Work, and Budget to the Department of Human Services/Division of Alcohol and Substance Abuse, and authorizes expenditures in accordance to the attached budget modifications.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided, however that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 22ND. day of NOVEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


