structure combining the Health Department, Department  
of Social Services and the Needy Family Food Program  
into the "DEPARTMENT OF HUMAN SERVICES"; and**

**WHEREAS, any amendments affecting the Scope of Work or funding  
levels of the contract shall be submitted for review and  
approval; and**

**WHEREAS, the Department of Human Services requests the  
following program title change: Readiness Employment  
Assistance Program (REAP)/Division of Family Assistance  
Services; and**

**WHEREAS, the Department of Human Services//Division of Family  
Assistance Services, the Readiness Employment  
Assistance Program has submitted a revised Scope of  
Work and budget modification for review and approval  
by the Tohono O'Odham Legislative Council.**
