**WHEREAS, the Tohono O'Odham Nation is presently operating the
Psychological Services Program under P. L. 93-638
contract with the Public Health Services, Indian Health
Services; and**

**WHEREAS, Resolution No. 94-393 approved the consolidation
structure combining the Health Department, Department
of Social Services and the Needy Family Food Program
into the "DEPARTMENT OF HUMAN SERVICES"; and**

**WHEREAS, any amendments affecting the Scope of Work or funding
levels of the contract shall be submitted for review and
approval; and**

**WHEREAS, the Department of Human Services requests the
following program title change: Division of Psychological
Services; and**

**WHEREAS, the Department of Human Services/Division of
Psychological Services has submitted a revised Scope of
Work and budget modification (Children's Initiative
Funds) for review and approval by the Tohono O'Odham
Legislative Council.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative
Council that the Tohono O'Odham Nation's Officials, to
wit: the Chairman and any designated official are hereby
authorized to negotiate and execute the contract,
provided, however that any amendments affecting the
funding or funding levels of this contract shall be
submitted for further prior approval by this Council.**

Legislative Council on the 22ND. day of NOVEMBER, 1994 at a
meeting at which a quorum was present with a vote of 1,763.0 FOR;
-0- AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the
powers vested in the Council by Section 1(f) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
