**WHEREAS, the Tohono O'Odham Nation is presently operating the
Adult Care Group Home Program under P. L. 93-638
Contract with the Bureau of Indian Affairs; and**

**WHEREAS, Resolution No. 94-393 approved the consolidation
structure combining the Health Department, Department
of Social Services and the Needy Family Food Program
into the "DEPARTMENT OF HUMAN SERVICES"; and**

**WHEREAS, any amendments affecting the Scope of Work or funding
levels of the contract shall be submitted for review and
approval; and**

**WHEREAS, the Department of Human Services requests the
following program title change: Adult Care Group
Home/Division of Senior Services; and**

**WHEREAS, the Department of Human Services/Division of Senior
Services, Adult Care Group Home has submitted a revised
Scope of Work and budget modification for review and
approval by the Tohono O'Odham Legislative Council.**

**NOW, THEREFORE BE IT RESOLVED by the Tohono O'Odham
Legislative Council that it does hereby approve the
revisions to the Program Title; Scope of Work and
Budget Modification to the Department of Human**

authorized to negotiate and execute the contract,
provided, however that any amendments affecting the
funding or funding levels of this contract shall be
submitted for further prior approval by this Council.**

meeting at which a quorum was present with a vote of 1,763.0 FOR;
-0- AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the
powers vested in the Council by Section 1(f) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
