3 **WHEREAS, the National Indian Education Association (NIEA) has**  
4 **scheduled its annual convention in Tucson, Arizona on**  
5 **November 11-15, 1995; and**

6 **WHEREAS, the San Xavier District of the Tohono O'odham Nation, the**  
7 **Council on Excellence in Education for Native Americans**  
8 **and the Arizona Indian Education Association has been**  
9 **planning this convention since February 1992; and**

11 **WHEREAS, the NIEA Convention is designed to bring together**  
12 **educators, students, parents, and friends of Indian**  
13 **Education to exchange ideas, promote successful**  
14 **programs and to encourage students to attain their**  
15 **educational goals; and**

18 **WHEREAS, this convention will benefit all participants, but most**  
19 **importantly, the Tohono O'odham Nation and the Native**  
20 **American population based in Tucson, and Arizona**  
21 **Indian Nations and the Native American urban**

24 **WHEREAS, the NIEA-AZ-95 Planning Committee has requested**  
25 **\$10,000.00 from each tribe to assist in the planning**

28 **WHEREAS, it would be in the best interest of the Tohono O'odham**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham  
Legislative Council, hereby, appropriates the amount of  
\$20,000.00, to the NIEA-AZ-95 Planning Committee for its  
efforts in planning the NIEA 1995 Convention in  
Tucson.**

**The foregoing Resolution was passed by the Tohono O'odham  
Legislative Council on the 22ND. day of NOVEMBER, 1994 at a  
meeting at which a quorum was present with a vote of 1,619.5 FOR;  
-0- AGAINST; 143.5 NOT VOTING; and 05 ABSENT, pursuant to the  
powers vested in the Council by Section 1(d) of Article VI of the  
Constitution of the Tohono O'odham Nation, adopted by the Tohono  
O'odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
