**RESOLUTION NO. 94-500**

**WHEREAS, the Gu-Vo Council did hold a meeting on November 16,  
1994 at which they authorized to modify and transfer of  
their FY'94 into the FY'95 budget line item -9300 to  
purchase a modular unit for district use; and**

**WHEREAS, monies modified from communities and any savings left  
in FY'94 district operations will be transferred to line  
item -9300 Capital Equipment in the FY'95 Budget; and**

**WHEREAS, the Tohono O'odham Legislative Council has reviewed  
the modifications and resolutions and finds it in order.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham  
Legislative Council hereby approves and authorizes the  
Gu-Vo modifications and carry-over of the Gu-Vo District  
monies into the FY'95 Budget Capital Equipment line  
item and authorizes expenditures therewith.**

**The foregoing Resolution was passed by the Tohono O'Odham  
Legislative Council on the 22ND. day of NOVEMBER, 1994 at a  
meeting at which a quorum was present with a vote of 1,500.0 FOR;  
-0- AGAINST; 263.0 NOT VOTING; and 06 ABSENT, pursuant to the  
powers vested in the Council by Section 1(d)(3) of Article VI of the  
Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
O'Odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
