4 **September 14, 1994 at which a quorum of seven (7)**  
5 **councilmembers were present, did at that time resolve**  
6 **the following; and**

7 **WHEREAS, the Governing Council did approve the Gaming Revenues**  
8 **to be distributed in these amounts:**

10 **District Operations: \$140,000.79 Invest: \$100,000.00**

11 **Four Communities \$122,058.00 @ \$30,514.50; and**

12 **WHEREAS, these amounts total the Gaming Revenues Allocation of**  
13 **Three Hundred Sixty-Two Thousand Fifty Eight Dollars**  
14 **and Seventy Nine Cents (\$362,058.79) and to include the**  
15 **transfer of FY'94 monies in the amount of \$23,455.74**  
16 **previously approved by Legislative Council Resolution**  
17 **No. 94-500 to be reflected in the FY'95 Gu-Vo District**  
18 **Budget for a total of \$385,514.53.**

22 **Legislative Council approves the Gaming Revenues to be**
