

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Fiscal Year 94/95 Budget
for San Xavier District)**

RESOLUTION NO. 94-510

WHEREAS, the Tohono O'Odham Legislative Council has dispersed the Gaming Revenue to all the Districts to meet their projected budget for fiscal year 94/95; and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed the projected expenditures for fiscal year 1994/1995 and has determined that the budget components are essential to meeting the needs of the San Xavier District Community; and

WHEREAS, the proposed budget has been reviewed with the San Xavier District Community members, at the San Xavier District meeting held on November 20, 1994 and approved by Resolution #SXDC 11-94-06.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council under the authority granted in the Tohono O'Odham Constitution, Article IX, Section (d)(3) that it hereby approves the fiscal year 1994/1995 budget in the amount of One Million, Seven Hundred Seventy-Seven Thousand Nine Hundred Sixty-One Dollars and Forty-One Cents (\$1,777,961.41) for the San Xavier District.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 07TH day of DECEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,183.0 FOR; 226.0 AGAINST; 354.0 NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




