RESOLUTION NO. 94-512

**WHEREAS, the Tohono O'Odham Nation's fiscal year for FY-94 ended
on September 30, 1994; and**

**WHEREAS, the Legislative Council by Resolution No. 94-440 did
approve a continuing resolution for the Law
Enforcement Services which expires November 18, 1994;
and**

**WHEREAS, the Law Enforcement received a special appropriation in
the amount of \$2,839,558 in December of 1993 from
Tohono O'Odham Nation funding; and**

**WHEREAS, it is the Tohono O'Odham Nation's desire not to interrupt
the special appropriation funding for the Law
Enforcement; and**

**WHEREAS, the Budget & Finance Committee and the Executive
Office have not reviewed accounting of all expenses from
the special appropriation; and**

**WHEREAS, the Budget & Finance Committee and the Executive
Office agree on a continuing resolution so that the
oversight committees can thoroughly review the
proposed budget.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it
hereby authorizes the Law Enforcement to continue**
