

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Payment of Christmas Bonus)**

RESOLUTION NO. 94-516

WHEREAS, the Legislative Council believes that all employees and officials of the Tohono O'odham Nation's three government branches, including employees of the Tohono O'odham Housing Authority and employees and officials of Desert Diamond Casino receive a Christmas bonus; and

WHEREAS, the Legislative Council has decided that the amount of \$500.00, the same amount that was distributed last year, be given to each employee and official, without deduction of taxes; and

WHEREAS, the total number of employees and officials that will be granted the bonus and the amounts are as follows:

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham

Legislative Council does hereby approve and appropriate the amount of \$632,000.00 to provide a Christmas Bonus payment to all employees, appointed, and elected officials of the Nation's three government branches, including employees of the Tohono O'odham Housing Authority and employees and officials of Desert Diamond Casino.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that an additional amount of \$96,696.00 be appropriated to satisfy tax withholding obligations.

BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council does hereby approve and appropriate a total amount of \$728,696.00 from the Special Reserve Account to provide for Christmas Bonus payments.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 8TH. day of DECEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,057.0 FOR; 301.0 AGAINST; 115.0 NOT VOTING; and 290.0 [10] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
