provision of HB 1348, the AHCCCS Omnibus Bill; and**

**WHEREAS, since 1990, by Resolution Nos. 37-90, 91-466, and 93-143,  
the Tohono O'Odham Legislative Council has supported  
Councilman Alex Ramon's participation on this Advisory  
Council; and**

**WHEREAS, Councilman Ramon has again been recommended for  
appointment to serve on the Advisory Council on Indian  
Health Care to assist in providing health services for the  
Indian people of the State of Arizona; and**

**WHEREAS, Willard Anita, as Chairman of the Health and Human  
Services Committee, is eminently qualified to serve the  
Indian Nations and People of Arizona and the State of  
Arizona.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
Legislative Council does hereby support and confirm the  
appointment of Willard Anita, Chairman of the Health &  
Human Services Committee to the State Advisory Council  
on Indian Health Care.**

Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
O'Odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
