NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby reappoints Lucilda Norris as a full-time Judge of the Tohono O'odham Courts for a six year term with said term to expire on February 01, 2001.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 9TH. day of DECEMBER, 1994 at a meeting at which a quorum was present with a vote of 941.0 FOR; 571.0 AGAINST; 251.0 NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Section 4 of Article VIII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
