

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Nicholas Lewis as Judge of the
Tohono O'odham Courts)**

RESOLUTION NO. 94-524

**WHEREAS, Section 4 of Article VIII of the Constitution of the Tohono
O'odham Nation charges the Tohono O'odham Legislative
Council the responsibility of appointing judges of the
Tohono O'odham Courts; and**

**WHEREAS, a vacancy exists for one full-time Judge's position to fill
the expired six year term of former Judge Antone M.
Chico, Jr.; and**

**WHEREAS, the Legislative Council did interview the candidate for
the Judge's position and reviewed the candidate's
qualifications.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham
Legislative Council that it hereby appoints Nicholas Lewis
as a full-time Judge of the Tohono O'odham Courts for a
six year term with said term to expire on February 01,
2001.**

**The foregoing Resolution was passed by the Tohono O'Odham
Legislative Council on the 9TH. day of DECEMBER, 1994 at a meeting
at which a quorum was present with a vote of 799.0 FOR; 676.0
AGAINST; 288.0 NOT VOTING; and 05 ABSENT, pursuant to the
powers vested in the Council by Section 4 of Article VIII of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
