**RESOLUTION NO. 94-529**

**WHEREAS, on December 7, 1994, the issue of distributing Christmas Bonuses for the Pisinemo District Employees, District Council, and four Alternates was presented to a majority of the Pisinemo District Council via telephone; and**

**WHEREAS, an addition of \$9,500.00 to the Pisinemo District's FY-95 Budget for the distribution of \$500.00 for 6 employees, \$500.00 for 11 District Council Members, and \$250.00 for 4 Alternates was presented and agreed upon by a majority vote of the Pisinemo District Council.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby approves the addition of \$9,500.00 to the Pisinemo District's FY-95 Budget for distribution of Christmas Bonuses for the Pisinemo District Employees, District Council, and Four Alternates.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 09TH. day of DECEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,246.0 FOR; -0- AGAINST; 287.0 NOT VOTING; and 230.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
