**WHEREAS, by Resolution No. 94-463, the Tohono O'Odham
Legislative Council approved an attorney contract with
the law firm of Shimmel, Hill, Bishop and Gruender to
provide legal representation for clients of the Office of
the Advocate; and**

**WHEREAS, the attorney contract will expire on December 31, 1994;
and**

**WHEREAS, continued legal representation for clients of the Office of
the Advocate is presently required until February 3, 1995;
and**

**WHEREAS, the Office of the Advocate has requested authority to
reprogram \$19,972.00 from line items 010 and 020 to line
item 060, Professional Services, of the FY-95 approved
Budget, to fund this contract; and**

**WHEREAS, the Tohono O'Odham Legislative Council has now
reviewed this matter and finds that it is in the best
interest of the Nation to approve Budget Modification No.
2 and the contract with the Shimmel Firm.**
