**LEGISLATIVE ORDER NO. 94-537**

**WHEREAS, by Legislative Order No. 93-157, the Legislative Council  
did certify a Two-Year Term for Legislative Secretary,  
Teresa M. Choyguha, ending in June of 1995; and**

**WHEREAS, the Legislative Council did by Legislative Order No.  
94-400, accept the resignation of Legislative Secretary,  
Teresa M. Choyguha; and**

**WHEREAS, it is necessary to appoint a Legislative Secretary; and**

**WHEREAS, Section 5 of Article VI of the Constitution of the Tohono  
O'Odham Nation requires the Tohono O'Odham  
Legislative Council to select a Secretary from without its  
membership; and**

**WHEREAS, the Legislative Council did conduct interviews for the  
Legislative Secretary and finds that Frances Antone does  
have the necessary qualifications for the position of  
Legislative Secretary.**

**NOW, THEREFORE, BE IT ORDERED that the Tohono O'Odham  
Legislative Council hereby appoints and confirms Frances  
Antone as Secretary for the Tohono O'Odham Legislative  
Council.**

**M. Choyguha.**


**The foregoing Legislative Order was passed by the Tohono O'Odham**

**powers vested in the Council by Section 1(b) of Article VI of the**  
**Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
**O'Odham Nation on January 18, 1986; and approved by the Acting**  
**Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
**1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
