4 **Resolution No. 94-404 approve the FY 1995 Projected**
5 **Revenues at \$15,655,000; and**

6 **WHEREAS, the Budget & Finance Committee is empowered to review**
7 **and recommend measures or actions to the Tohono**
8 **O'odham Legislative Council regarding appropriating for**
9 **expenditure of funds; and**

11 **WHEREAS, review of the current level of appropriations by the**
12 **Tohono O'odham Legislative Council necessitates**
13 **revision of the FY 1995 Revenue Projection; and**

15 **WHEREAS, the Tohono O'odham Legislative Council for FY 1995**
16 **distributed funds from the Nation's Casino for Operation**
17 **Expenses, based on a formula to the Nation and Districts;**

20 **WHEREAS, there remains a balance in the Nation's share of**
21 **\$3,275,489.19 and the Budget and Finance Committee is**
22 **recommending this amount be added to the Revenue**
23 **Projections for FY 1995.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham**
25 **Legislative Council that it hereby approves the attached**
26 **revised FY 1995 Projected Revenues to be increased by**
27 **\$3,275,489.19 for a revised total of \$18,930,489.19.**


