**RESOLUTION NO. 94-547**

**WHEREAS, by Resolution No. 94-516, the Legislative Council did  
approve payment of a Christmas Bonus in the amount of  
\$500.00 to all employees and officials of the Tohono  
O'Odham Nation's three government branches, including  
employees of the Tohono O'Odham Housing Authority  
and employees and officials of Desert Diamond Casino;  
and**

**WHEREAS, these individuals (see attachment) have been working  
and have been categorized as "casual labor", but has  
served the Nation faithfully and therefore should be able  
to receive the same treatment as other employees who  
work for O'Odham Construction & Materials, in regard to  
Christmas bonus only for FY 1995.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
Legislative Council does hereby approve and appropriate  
the amount of \$8,071.00 to provide a Christmas Bonus  
payment to the 15 people categorized as "Casual Labor"  
(see attachment).**

Council does hereby approve and appropriate a total**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 20TH. day of DECEMBER, 1994 at a meeting at which a quorum was present with a vote of 1,102.0 FOR; 329.0 AGAINST; 181.0 NOT VOTING; and 151.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


