3 **WHEREAS, the Tohono O'Odham Utility Authority proposes to construct a**

5 **Water Right-of-Way to Ali Chugk Community, of the Gu-Vo District,**

7 **and has submitted a plat or map thereof to the Tohono O'Odham**
8 **Legislative Council showing the location and scope of the easement**
9 **and delineating the utility facilities to be placed thereon; and the**
10 **total length of the line for Ali Chugk Water Right-of-Way is**
11 **5986.31' feet in length, 40' feet in width and 5.727 acres in size (or**
12 **area); and**

16 **WHEREAS, the Tohono O'Odham Legislative Council has determined that the**
17 **routing and location of the easement for the new Water Right-of-**
18 **Way facilities is not in conflict with any land use plans adopted by**
19 **the District Council and approved by the Tohono O'Odham Council,**
20 **and that the new Right-of-Way will be of substantial benefit to the**
21 **Community of Ali Chugk, Gu-Vo District, Tohono O'Odham Nation**
22 **and to their respective members.**

12 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
13 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
14 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


