RESOLUTION NO. 95-006

WHEREAS, the Tohono O'Odham Patient Dialysis Council has special needs deriving from their serious medical conditions and are thereby prohibited from participating in extended fundraising activities for all practical purposes; and

WHEREAS, the goals of the Patient Dialysis Council are:

- to provide safe, efficient, and comfortable dialysis in a pleasant atmosphere;**
- to improve the quality of its patient's lives; and**
- as well as to accommodate its patients to a useful life will be greatly facilitated by approval of this budget request.**

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'Odham Nation hereby approves the FY '95 Special Appropriations Budget for the Tohono O'Odham Patient Dialysis Council in the amount of \$10,000.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 09TH day of JANUARY, 1995 at a meeting at which a quorum was present with a vote of 1,763,0 FOR; -0- AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono






