**RESOLUTION NO. 95-013**

**WHEREAS, the Tohono O'Odham Nation is presently operating the Job Training Partnership Act (J.T.P.A.) Programs; and**

**WHEREAS, funding is available to contract youth employment/training services to establish programs for improving the employment/training prospects of eligible persons; and**

**HEREAS, the Tohono O'Odham Nation is entitled to JTPA funds to develop a network of employment and training programs throughout the Nation; and**

**WHEREAS, it is the purpose of the JTPA Title II-C Youth Training Programs to improve the long-term employability through the enhancement of the education, occupations, and citizenship skills; to encourage school completion from high school or an alternative school; to increase the employment earnings; to reduce welfare dependency and to assist youth in addressing problems that impair their ability to make successful transitions from school to work, apprenticeship, military or post secondary education and training; and**

**WHEREAS, the Tohono O'Odham Nation, JTPA Programs desire to contract with Tohono O'Odham High School to conduct a school-wide project entitled: Alternative Learning Program/Work Experience for the period of November 15, 1994 through September 30, 1995.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves the Cooperative Agreement between the Tohono O'Odham Nation, JTPA Programs and Tohono O'Odham High School to conduct a school-wide project entitled: Alternative Learning Program/Work Experience to the Tohono O'Odham members.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the Agreement, provided however, that any amendments affecting the funding or funding levels of the Agreement shall be submitted for further prior approval by this Council.**


