3 **WHEREAS, the Legislative Council by Resolution No. 95-015 did approve and**

5 **appropriate the formation of a \$13,500,000., Set-Aside Budget for the**

7 **Nursing Home Project from the Nation's Distribution Share Account**

10 **WHEREAS, the correct total amount of said budget should be \$14,850,000.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**

13 **Council that it hereby amends Resolution No. 95-015 to change the**

15 **total amount of \$13,500,000., to \$14,850,000., for the Set-Aside**

17 **Budget for the Nursing Home Project.**

19 **on the 12TH day of JANUARY, 1995 at a meeting at which a quorum was**
20 **present with a vote of 1,467.0 FOR; -0- AGAINST; 296.0 NOT VOTING; and 03**
21 **ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of**
22 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
24 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
25 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
