Nation Account to Paine & Webber)

RESOLUTION NO. 95-021

WHEREAS, the Tohono O'Odham Legislative Council by Resolution #331 did
approve gaming revenue equal distribution to the eleven political
districts of the Tohono O'Odham Nation; and

WHEREAS, the Hickiwan District was allocated Three Hundred Sixty-Two
Thousand, Fifty Eight Dollars and Seventy-Nine Cents (\$362,058.79);
and as of June 94 a bank balance of One Thousand Five Hundred
Twenty-Three Dollars and Eight-Four Cents (\$1,523.84) and an
investment of One Hundred Forty-Five Thousand Dollars
(\$145,000.00) which amounts to \$146,523.84; and

WHEREAS, the District Administration has been working with Wayne Griffith as
a consultant to establish the district account under Paine & Webber;
and

WHEREAS, the District needs to establish an accounting system that is workable
to the needs of the district and the accountability of funds and to
take advantage of higher rate of interest investment; and

WHEREAS, on November 12, 1994 the transfer of funds was presented to the

District Council in detail, the reason the administration wanted to do this.

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby

approve the transfer of Hickiwan District Funds Account No.

92-0004-181 under Tribal Accounting to Paine & Webber.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13TH day of JANUARY, 1995 at a meeting at which a quorum was present with a vote of 1,485.0 FOR; -0- AGAINST; -0- NOT VOTING; and 278.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
