RESOLUTION NO. 95-023

WHEREAS, the Tohono O'Odham Nation is presently operating the Law Enforcement & Detention Services Program under FY 1995 P. L. 93-638 contract with the Bureau of Indian Affairs; and

WHEREAS, such funds are available for obligation to reflect additional funding for FY 1995; and

WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and

WHEREAS, an amendment has been submitted for review and approval by the Law Enforcement & Detention Services Program.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the amendment to the Law Enforcement & Detention Services Program contract and authorizes expenditures in accordance with the attached budget.

pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






