RESOLUTION NO. 95-024

WHEREAS, the Tohono O'Odham Authority Gaming Charter calls for the appointment of the Tohono O'Odham Gaming Authority Board of Directors by the Chairman of the Tohono O'Odham Nation, with the approval of the Legislative Council; and

WHEREAS, nominations were received, and Barbara Enos agreed to serve on the Tohono O'Odham Gaming Board of Directors for the following term of office:

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby appoint Barbara Enos to serve on the Tohono O'Odham Gaming Authority Board of Directors for a term beginning October 1, 1994 - September 30, 1995.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13TH day of JANUARY, 1995 at a meeting at which a quorum was present with a vote of 1,372.0 FOR; -0- AGAINST; 113.0 NOT VOTING; and 278.0[05] ABSENT, pursuant to the powers vested in the Council by Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
