H54-02-94, was discussed for approval; and

WHEREAS, a copy of Lease No. H54-02-94 was distributed to each of the 11
Pisinemo District Council members for their review prior to this
meeting; and

WHEREAS, the decision to accept Lease No. H54-02-94 as it is written or make
changes as necessary was the intent on this topic.

NOW, THEREFORE, BE IT RESOLVED that the Pisinemo District Council members
did review Lease No. H54-02-94 and further discussion was held at

BE IT FINALLY RESOLVED that the Legislative Council of the Tohono O'Odham Nation has accepted Lease No. H54-02-94 between the Tohono O'Odham Nation and Travis Robinette as it was made and written on the 1st. day of December, 1994, by and between Tohono O'Odham Nation and Travis Robinette, DBA Pisinemo Treading Post.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13TH. day of JANUARY, 1995 at a meeting at which a quorum was present with a vote of 1,485.0 FOR; -0- AGAINST; -0- NOT VOTING; and 278.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 2(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
