RESOLUTION NO. 95-032

WHEREAS, the traditional language of the Tohono O'odham is a vital part of
today's education for our people. Speaking the O'odham language
will lead to better understanding and maintaining our culture.

WHEREAS, the University of Arizona/Pima Community College Southwestern
Language Articulation Task Force group, will be seeking funding
through grants to enhance the language courses at both institutions.

WHEREAS, the grant monies when acquired, will be used to develop teaching
curriculum, language tapes, textbooks, and teaching methods for the
language faculty.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation, that it
supports and endorses the University of Arizona/Pima community
College Southwestern Language Articulation Task Force group, in its
filing of applications to seek funding from any agency for grant
monies. For the purpose of language enhancement.

on the 13TH day of January, 1995 at a meeting at which a quorum was present
with a vote of 1,485.0 FOR; -0- AGAINST; 62.0 NOT VOTING; and 278.0


