**RESOLUTION NO. 95-037**

**WHEREAS, the Tohono O'Odham Nation is presently operating the JTPA Title IIC Administrative Cost Pool and Program budget under an FY 1995 Contract with the State of Arizona; and**

**WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval by the JTPA Title IIC Program to reflect final allocation.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the amendment to the JTPA Title IIC/ACP/Program components and authorizes expenditures in accordance with the attached budgets.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.**






