5 IIA Administrative Cost Pool budget under an FY 1995 Contract
6 with the State of Arizona; and

8 **WHEREAS,** any amendments affecting the funding or funding levels of the
9 contract shall be submitted for review and approval by the Tohono
10 O'Odham Legislative Council; and

12 **WHEREAS,** an amendment has been submitted for review and approval by the
13 JTPA Title IIA Program.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'Odham Legislative
16 Council does hereby approve the amendment to the JTPA Title
17 IIA/ACP Program and authorizes expenditures in accordance with
18 the attached budget.

20 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council that the
21 Tohono O'Odham Nation's Officials, to wit: the Chairman and any
22 designated official are hereby authorized to negotiate and execute
23 the contract, provided however, that any amendments affecting the
24 funding or funding levels of the contract shall be submitted for
25 further prior approval by this Council.


