RESOLUTION NO. 95-039

WHEREAS, the Tohono O'Odham Nation is presently operating the JTPA Title IV Administrative Cost Pool under an FY 1995 Grant with the United States Department of Labor; and

WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and

WHEREAS, an amendment has been submitted for review and approval by the JTPA Title IV ACP Program.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the amendment to the JTPA Title IV ACP Program budget.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.




