4 **WHEREAS, the Tohono O'odham Legislative Council did by Resolution 95-028**
5 **approve the appointment of Ms. Alice Paul to the Tohono O'odham**
6 **Gaming Board of Directors; and**

8 **WHEREAS, upon presentation of Resolution No. 95-028 to the Chairman of the**
9 **Tohono O'odham Nation, he did disapprove thereof and returned**
10 **it to the Council with his objections in accordance with the**
11 **provisions of Article VII, Section 5 of the Constitution of the Tohono**
12 **O'odham Nation; and**

15 **WHEREAS, the Tohono O'odham Legislative Council has reviewed the**
16 **Chairman's objections and after consideration, again voted to pass**
17 **Resolution No. 95-044.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative**
20 **Council does hereby override the Chairman's veto of Resolution No.**
21 **95-028 by a vote of two-thirds of the votes cast.**

24 **The foregoing Resolution was presented to the Tohono O'odham Legislative**
25 **Council on the 06TH, day of February, 1995 at a meeting at which a quorum was**
26 **present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and**
27 **[07] ABSENT, was passed by a majority of at least Two-Thirds (2/3) 1,523.0 of**
28 **the votes cast and became law as provided in Section 5 of Article VII of the**
Constitution of the Tohono O'odham Nation.


