(Certifying the Appointment of Dennis Ramon as Legislative Vice Chairperson)

LEGISLATIVE ORDER NO. 95-048

WHEREAS, the Legislative Council on June 7, 1993 did by Legislative Order No. 93-156, certify the election of Earl A. Francisco as Vice Chairman of the Tohono O'Odham Legislative Council for a two-year term; and

WHEREAS, Earl A. Francisco did submit his resignation as Vice Chairman of the Tohono O'Odham Legislative Council, effective January 20, 1995; and

WHEREAS, the Legislative Council by Resolution No. 95-045 did accept the resignation of Earl A. Francisco as Legislative Representative of Baboquivari District, thereby effectuating a vacancy in the Legislative Vice Chairman position; and

WHEREAS, the Tohono O'Odham Legislative Council proceeded with nominations of a Legislative Vice Chairperson; and

WHEREAS, Dennis Ramon having received a majority of the votes cast, was appointed Vice Chairperson of the Tohono O'Odham Legislative Council.

13 and 05 ABSENT, pursuant to the powers vested in the Council by Section 1(b)
14 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
15 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
16 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
