**The foregoing Resolution was passed by the Tohono O'Odham Council on the**  
**6TH. day of FEBRUARY, 1995, at a meeting at which a quorum was present**  
**with a vote of 1,514.0 FOR; 75.5 AGAINST; 173.0 NOT VOTING; and 05 ABSENT;**  
**pursuant to the powers vested in the Council by Section 3 of Article II and**  
**Article VI Section 1 (h) of the Constitution of the Tohono O'Odham Nation,**  
**adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by**  
**the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
**1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
