

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Budget Modification regarding new Salary amounts and other items for
Indian Environmental General Assistance Grant)

RESOLUTION NO. 95-055

WHEREAS, the Legislative Council of the Tohono O'odham Nation is authorized
by the Tohono O'odham Constitution to adopt, approve and amend
annual budgets and to authorize the expenditure of funds in
accordance with these budgets; and

WHEREAS, the Planning & Operations Department through consideration, has
determined that:

- (1) the workloads for the positions of Environmental Manager and**
Assistant Environmental Specialist are substantially equal;
- (2) the large discrepancy between the salaries for these positions**
does not reflect that equality;
- (3) this situation could best be remedied by creating two (2)**
positions entitled Environmental Specialist. The persons hired
for these positions would serve the same duties formerly
performed by the Environmental Manager and Assistant
Environmental Specialist. Each position's salary would be
determined by dividing the former total salary in half,


