

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Reaffirming Council Resolution No. 18-83)**

4 **WHEREAS,** by Council Resolution No. 18-83, the Nation affirmed its claim to all
5 of the lands constituting the Baboquivari Peak and Mountain as the
6 central sacred and cultural site of its people, and demanded that
7 the lands constituting the eastern slope of Baboquivari Peak and
8 Mountain which are not held in trust by the United States for the
9 benefit of the Nation be transferred to such trust status for the
10 benefit of the Nation's; and

14 **WHEREAS,** Resolution No. 18-83 directed that all necessary steps be taken to
15 accomplish such transfer of those lands to the Nation; and

17 **WHEREAS,** such lands have not yet been transferred into trust for the benefit
18 of the Nation; and

20 **WHEREAS,** it is in the Nation's interest that such lands be transferred into
21 trust for the benefit of the Nation.

22 **NOW, THEREFORE, BE IT RESOLVED** that 1. Council Resolution No. 18-83 is
23 hereby reaffirmed. 2. The Chairman of the Nation and the
24 Cultural Preservation Committee of the Legislative Council are
25 hereby authorized and directed to take all steps necessary to have
26 all of the lands constituting the Baboquivari Peak and Mountain
27 which are not now held in trust by the United States for the

benefit of the Nation, transferred into trust and included within the
Tohono O'odham Reservation. Constitutional Authority: Article VI
Section 1(f), 2(d) and Article XVI Section 9.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council
on the 10TH, day of February, 1995 at a meeting at which a quorum was
present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and
[04] ABSENT, pursuant to the powers vested in the Council by Section 1(f), 2(d)
and Article XVI Section 9 of the Constitution of the Tohono O'Odham Nation,
adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
