4 **WHEREAS,** the Tohono O'Odham Nation is presently operating the Johnson
5 O'Malley Program under FY 1995 P.L. 93-638 contract with the
6 Bureau of Indian Affairs; and

8 **WHEREAS,** such tribal operations have been successful and beneficial to the
9 Tohono O'Odham Nation and its people; and
10

11 **WHEREAS,** any amendments affecting the funding or funding levels of the
12 contract shall be submitted for review and approval by the Tohono
13 O'Odham Legislative Council; and

16 **WHEREAS,** an amendment has been submitted to reflect the decrease of the
17 Indirect Cost from 30.7% to 15.5% and balance distributed into
18 other line items; and

21 **WHEREAS,** the Tohono O'Odham Legislative Council has reviewed and
22 approved the amendment for the FY 1995 Johnson O'Malley
23 Program.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'Odham Legislative
26 Council does hereby approve the amendment for the Johnson
27 O'Malley funds and authorizes expenditures in accordance with the

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated Official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH day of FEBRUARY, 1995 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
