4 **WHEREAS,** a goal of the Tohono O'odham Library Services is to automate all
5 libraries on the Tohono O'odham Nation, beginning with the Venito
6 Garcia Library; and

8 **WHEREAS,** the Tohono O'odham Education Department (Venito Garcia Library)
9 is applying for a grant, the Library Services and Construction Act,
10 Title II, through the State of Arizona Department of Libraries,
11 Archives & Public Records in the amount of \$5,000.00; and

14 **WHEREAS,** the proposal requires 50% matching funds from the Tohono
15 O'odham Nation (\$5,000.00 from the Nation and \$5,000.00 from the
16 State); and

19 **WHEREAS,** automating the library will greatly improve and enhance services
20 which will benefit all patrons utilizing the library.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative
23 Council does hereby approve applying for the Library Services and
24 Construction Act Title II proposal in the amount of \$5,000.00, with
25 the 50% matching from the Tohono O'odham Nation in the amount
26 of \$5,000.00.

10 amendments affecting the funding or funding levels of the grant
11 shall be submitted for further prior approval by this Council.

14 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council
15 on the 10TH day of FEBRUARY, 1995 at a meeting at which a quorum was
16 present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 05
17 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article
18 VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
19 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
20 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
21 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
