**RESOLUTION NO. 95-075**

**WHEREAS, the Tohono O'odham Nation is presently operating the Readiness Employment Assistance Program under an FY 1995 P.L. 93-638 contract with the Bureau of Indian Affairs; and**

**WHEREAS, the Nation was informed of an additional \$195,000.00 for the Readiness Employment Assistance Program in September, 1994 and was obligated in the Fiscal Year 1994 contract on September 27, 1994; and**

**WHEREAS, due to the late notice of additional funds the Nation request the deobligation of the \$195,000.00 from the Fiscal Year 1994 Contract #1450CTH54T61055 and reobligation in the Fiscal Year 1995 Readiness Employment Assistance Program Contract; and**

**WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval reflecting additional funds in the amount of \$195,000.00 by the Readiness Employment Assistance Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the amendment to the Readiness**

14 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the  
15           **Tohono Nation's Officials, to wit: the Chairman and any designated**  
16           **official are hereby authorized to negotiate and execute the contract,**  
17           **provided however, that any amendments affecting the funding or**  
18           **funding levels of the contract shall be submitted for further prior**  
19           **approval by this council.**

**Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




