The foregoing Resolution was passed by the Tohono O'Odham Council on the 06TH, day of MARCH, 1995 at a meeting at which a quorum was present with a vote of 1,379.0 FOR; -0- AGAINST; -0- NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the Council by Section 1 of Article II and Section 1 (h)


