

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Career Center FY-96 Appropriations Request)**

RESOLUTION NO. 95-086

WHEREAS, the Tohono O'odham Nation Career Center provides Apprenticeship training to the adult population of the Tohono O'odham Nation and other Indian Nations; and

WHEREAS, the Tohono O'odham Career Center proposes to add a State-of-the-Art Culinary Training Program to the existing Career Center's Programs in order to increase job placement opportunities for the members of the Tohono O'odham Nation.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby urgently request that Congress increase its appropriation for the Career Center for the Tohono O'odham Nation and that the appropriate officers of the Nation are hereby authorized and directed to bring this request to the appropriate members and committees of Congress.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 06TH, day of March, 1995 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 07 ABSENT, pursuant to the powers vested in the Council by Section 1(j) and Article XVI Section 9 of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






